Campus Improvement Plan



- HSA-SL blue print for improvement

- Continuously reviewed to check for implementation and progress

Why do we need CIP?

Campus Improvement Plan

- Establishes what staff is responsible for in relationship to learning (goals / performance objectives) and teaching (strategies /activities)
 - --Required through SB1, Title I, State Compensatory Education, and other programs
- 2. Provides "focus" for school improvement and maintenance efforts
- 3. Serves as a primary audit document



Title I, Part A

- Means we receive federal funding (Title I dollars) to supplement the school's existing programs. These dollars are used for...
- 1. Identifying students experiencing academic difficulties
- 2. Purchasing supplemental staff/programs/materials/supplies
- 3. Parent Rights at a Title I School
 - 1. Participate in meeting: we conducting parental Involvement meetings/trainings/activities
 - 2. Parents can be involved in decisions regarding funds that will be used for parent and family engagement



Schoolwide Campus

Title I campuses with percentages of students from low-income families of at least 40% may use Title I funds, along with other federal, state and local funds and may operate a "schoolwide program" to:

Upgrade the entire educational program

Raise academic achievement for ALL students

1% Set - Aside

- Our district (LEA) by law has set aside 1% for Title 1 allocation for parent and family engagement
 - Parents can be involved in decision of the 1% set aside for both for system-wide initiatives and school-level activities.

Continuous Improvement Plan (C.I.P.)

- Includes:
 - A Needs Assessment and Summary of Data
 - Goals, objectives and strategies to address academic needs of students
 - Professional Development Needs
 - Coordination of Resources/Comprehensive Budget
 - Identification of Title I funds and expenditures
 - Strategies from school's parental involvement policy
- Parents can be involved in development of the CIP Committees
 - Completed copy of CIP will be on our school website

Parent and Family Engagement Policy

- Is apart of the CIP; designed to increase student achievement
- This policy addresses how the school will implement the parent and family engagement program. The policy includes:
 - Convene annual meeting
 - Involve parents in an organized, ongoing, and timely way, in the planning, review, and improvement of the parent and family engagement activities
 - Provide timely information about parent and family engagement activities
 - Provide information about curriculum and assessment
 - If requested, provide additional meetings with parents to discuss for the education of their child

Title I parents, have the right to be involved in the development of your school's Parental Involvement Plan

Title I parents, have the right to be involved in the development of your school's Parental Involvement Plan





- A written agreement that addresses:
 - High quality curriculum and instruction
 - How we can work as partners to improve student achievement
 - Parent Communication
 - Importance of involvement in your student education

Teacher Qualifications



- as Title I parents, they have the right, by law, to request the qualifications of their child's teachers
- NCLB requirement that Title I parents must be notified if their child has been assigned to or taught for four or more consecutive weeks by a teacher who is not Highly Qualified.

Annual Evaluation




- Parental Involvement Policy and Program is evaluated annually
